

## TERMS & CONDITIONS

## **WINNER NOTIFICATION**

11. The winning entrant, winning community group and runner-up community group will be notified in writing by email and phone within two (2) business days of the completion of tallying all entries.

## **PRIZES**

12. The total prize pool associated with this competition is as follows:

- The eligible community group with the most entries will WIN a \$2000 cash prize.
- The eligible community group with the second most entries will WIN a \$1000 cash prize.
